## HIGHLIGHTS OF ANNUAL SHAREHOLDERS MEETING Marty Krzyminski

## Saturday April 29, 2023,

**Meeting** called to order at\_9:02 AM, quorum of 27 shareholders.

**-We** have \$28,394.71 in checking and \$25,894.72 in money market. Total as of April 15, 2023 is \$54,289.43. 2022-2023 Income \$151,271.79, expenses \$178, 621.62 for a loss of -\$27, 349.83. April 2023 through March 2024 budget, estimated income \$148,800 and expenses \$131,000. SSYC's entrance channel dredging estimate \$52,366.44. Additional cost to remove dredged material form BCYC berm may be required.

-All contractors from last season have been retained.

- Last season 87% capacity 80 renters/78 owners. 12 slips sold from \$2000 to \$8,500 depending on size and location.

-We will be deemphasizing red violation tags and emphasizing incident reports. Improper cleats need to be replaced. Power cords need to be marine grade. Make sure your dock line size is appropriate for your boat and boat properly secured.

Dock boxes must be installed according to standards on website. Dock brackets are available for \$75.

**-Dredging** of entrance channel to 7' scheduled in May.

-Volunteer projects are posted on white boards in laundries. PLEASE HELP

-Hailors' are posted on the website.

**-Yearly** fee of \$20 to list your slip for rent on our website. Slips for sale have a one-time fee of \$20.

-Please keep your boats and docks in good shape.

- Seek help to raise or lower your dock if you have never done it before. A volunteer can do it for you for \$100 a dock.

-Website is a great source of information.

**-Outgoing** board members were recognized and we welcomed newly elected board members Charlie Brown, Mitch Prabucki, Paul VanTol, and Dennis Reinke.

## Welcome to SSYC!

\* Prior to any boat being put into a slip, a current mooring form and a copy of proof of insurance must be on file. (mooring forms can be accessed from the website and in the hallway by Community Room)

\*The section of the boat insurance policy must be submitted with the name of the insured clearly showing, the date of expiration, and a minimum of \$300,000 liability coverage.

## \*If your insurance expires during the boating season, a new insurance form needs to be submitted before the expiration date.

\*Please mark the slip number at the top of each page submitted. (*Please do not send the Lease Agreement to us. It is between owner and renter and is not needed by SSYC.*)

\*If anyone is selling their slip this year, please check the website for proper procedure and paperwork and contact me with questions and to get the sale completed.

## VIOLATIONS Charlie Brown

As a reminder; please make sure you, your guests and renters are familiar with SSYC rules and By-Laws. All documents are available on our website at sunsetshoresyachtclub.com.

A new rule was added to the *SUNSET SHORES YACHT CLUB ASSOCIATION RULES* book by the *SSYC* Board of Directors to address some issues that occurred during the 2018 season. **This rule went into effect in the 2019 season.** Our main goal for creating the new rule is to protect our member's boats, health and safety. The club is there for enjoyment and messy projects can seriously affect the enjoyment of your summer leisure time. Please use common sense when doing any kind of boat, dock box or other project while moored at *SSYC*.

From page 5 of the rule book:

26. Absolutely no wet sanding, no dry sanding (by hand or machine), no spray painting, or any unsightly boat projects will be allowed at SSYC. BOD members reserve the right to rule on any such projects to protect members boats and club enjoyment.

## DREDGING

We have contracted with a dredging company to remove spoils from the entrance channel in front of the BCYC seawall. They will be using a vacuum pipe system with the pipe running from their barge to the BCYC holding berm. The work is expected to start at the end of May and finish in about two weeks. Depth when complete should be seven feet. The channel may be blocked for long periods of time while the work is completed. Please be patient while this work is completed and check the location of the dredge BEFORE using the channel. Look for more detailed info on out WEBSITE.

#### OPERATIONS Mike Krzyminski

This year we will again be retaining all our regular service contractors including the cleaning contractor (A to Z Cleaning), grounds contractor (Forever Green) and sprinkler system (Precision Lawn Sprinklers).

A couple reminders: Please clean up after yourself in the restrooms and no not park on the grass where the sprinkler heads can be damaged.

If you have any concerns about the maintenance of the Club during the boating season, please contact any of the board members for a resolution of the problem.

We want to keep lights by your slips on, they are controlled by the breaker box switch on the right. Please keep it in the on position.

Board Member, Don Leidke, will again assume the duties of club maintenance person.

## **GOOSE CONTROL**

We have been working to keep the geese off the grass using variable means. You will see some netting on part of the rip-rap stones to keep them off as a trial. Additionally. we have found that tape or line run about 6" above the ground in front of a dock discourages them form walking on the dock. Running line or tape between the lawn and rip-rap stones often works too. Good Luck. Please do not feed or encourage the birds in general.

## **OIL BOOM**

The club has 40' of oil boom (4 boxes) stored in the east grill storage area. These boom sections are to be tied end to end with a small overlap to contain and absorb the spill around a boat or boats or across the waterway as we did with our first spill two seasons ago. We also have a box of oil absorbent pads stored in the west maintenance room. Contact any board member for access. These pads are used to float on the surface of the spill to absorb oil.

Please, ensure your bilges are clean and that oil and other pollutants are not pumped overboard by the bilge pump. Oil releases, no matter how small, are required by law to be reported.

## MEMBER PARTICIPATION COMMITTEE Dennis Reinke

Numerous projects were completed by the MPC last year and I would like to take this opportunity to thank all those who volunteered their time both Shareholders and Renters. Some of projects we need help with this summer include:

- -Power wash buildings, May-June
- -Weed spraying the Rip-rap, July/August
- -Bug control in and around buildings, Continuous
- -Paint bath house entrance floors-June

## **NEWS AND REMINDERS**

#### **ANTI-SIPHONING DEVICES**

Please do not remove the anti-siphoning devices from the hose hook ups. They are required by law to be there.

## **DOCK BOXES**

Please level up your dock boxes. Besides being unsightly, many are collecting rain water and providing breeding grounds for mosquitoes.

#### **DOCK MODIFICATIONS**

Modifications to your docks must meet club standards which require you to fill out a form to make those modifications. If your modifications are above or below the club standards then a variance must be applied for via a variance form, (See Don Leidke for forms). Owners please inform your renters of this requirement.

#### BIKE RACKS

Please use the racks and do not store bikes in the laundry rooms or back rooms of the bath houses.

#### **NO FISH GUTS IN THE DUMPSTERS**

**Please**, the dumpsters are not emptied often enough to make large deposits of fish guts in the dumpster acceptable.

### **CHILDREN SAFETY**

Life jackets are to be worn at all times by all unsupervised children twelve (12) years old or younger when on club property.

## PETS ON LEASH

Dogs must be kept on leashes when not on the boats of members, renters or guests. Please pick up after your pet, NO pets allowed in the club buildings.

#### PERSONAL STORAGE

Please refrain from using the laundry and/or maintenance rooms for storage of personal items.

## POWER SQUADRON

The power squadron will be at the club on June 10 to complete a boat safety inspection. Sign up at either club house building and be safe out there.

## **SPRINKLER SYSTEM**

Sprinkler heads are on the edge of the asphalt. Driving or parking on the grass damages them.

### SHORE POWER CORDS

For safety reasons, improper power cords should never be used. Power cords to provide shore power to individual boats must be of sufficient size to support the current rating of the breaker at the post and also must be grounded to reduce electrical shock hazards and prevent possible galvanic corrosion. Power cords must also be capable of withstanding the wet environment normally associated with marine use. Therefore, all power cords supplying power to boats in Sunset Shores Yacht Club must be three-conductor #10 marine grade AWG wire with insulation designed for use in wet environments. Where two cables are spliced together an approved marine grade connector must be used.

A cable not meeting this specification should never be used to connect shore power to your boat even for short periods of time and must not lie in the water at any time.

# These rules apply to the temporary use of vacuum cleaners, power washers, sump pumps, etc also.

Board members will take action if they note a violation of this guideline by **removal of any plug-in** that is not in compliance with the rules. The slip owner will be informed and an incident report will be filed in the offending slips file. Repeat violations could result in fines or possible banning of the vessel in the harbor
